6. Old Business:

***Vetted Missions: Jane Heinks came to answer questions about the Vetting Process

1. Goal:

a. We want to understand the process Jane went through the vetting on missions.

2. History of the Vetting Process:

a. In 2018, about five years ago, Father Michael Skluzacek asked Jane to 'handle' all the different missions' people calling and asking, 'could I come and do a fundraising at the Church?'

Partners 4 Hope Tanzania, a mission Fr. Skluzacek was familiar with.

- b. He commissioned Jane to look into this because she had gone to Tanzania & Liberia (2014)
- c. Jane tapped Mark Haidet who spent his entire career in fundraising for the Minnesota Historical Society, who then put together this process.
- d. When someone come to St. John asking if they can solicit funds from our parishioners, we ask them to fill-up this form and submit with it the documents of information listed here.

- e. Jane, Mark and René formed a sub-committee of POC which reviewed those submissions within a three-month period after the application is turned in.
- f. Approval is only for fundraising. It does not give you other privileges.
- g. At this point, if somebody goes through this vetting process, we can attest that these people have met these criteria.
 - We're saying we've done a minimum amount of vetting of these people are saying who they say they are, and this is what they propose to do.
- h. After the fundraising activity, they are expected to report back what they did with the funds:
 - To provide a report upon completion of funded activities
 - To submit a close of your fiscal year, describing the total funds raised from SJB,
 - to submit a description of how these funds were used and their impact on the community benefiting from SJB support.

3. Goals of Vetting:

- a. Partnership with outside organizations in the work of evangelization
- b. The process should not be an obstacle that would lessen their zeal for mission but should encourage the mission spirit.
- c. It gives our parishioner a small level of assurance that they're not-giving their money to just any person but to a legit organization.
- d. The point of this is that we can have an accountability to people who've asked us 'how the money that we're giving are being used?'
- e. We have to do the due diligence to say 'we've checked this out.

4. Documents:

- a. The letter to the Fundraising Applicant
- b. The Policy Statement: secure copies from Mark Dittman, Director of Business Operation

5. The Process Involved:

- a. POC vetting team will evaluate requests for financial support for such groups from SJB and community.
- b. The review includes the process to see if the applicant is a legitimate 501 C3 organization. and their financial statement, goals and all other documents
- c. This is the bar that we have set for the very real purpose of making sure the mission is legitimate.

6. Who qualifies?

- a. Applicant should be connected with the organization being applied for
- b. The applicant should be a Parishioner.

- c. Organization may either be international or a domestic mission.
- 7. The fundraising projects of the following are **exempt from the vetting process**:
 - a. Boy Scouts
 - b. Youths or High school students going on mission trips.
 - c. NET
 - d. FOCUS
 - e. Steubenville Franciscan
 - f. Knights of Columbus
 - g. St. Paul's Outreach
 - h. A college student who's under the umbrella of a reliable, known external entity.
- 8. What St. John has to offer the missions to be vetted? What are the missions getting once they're vetted?
 - The POC recorder handed over to Marie these proposals in a document reviewed by PLC in April
 - The opportunity to have a fundraising event 2x a year.
 - You can have a table in the plaza twice a year
 - A request has to be raised with the Leadership Team for their approval on date.
 - Each vetted mission will need a review after 3 years; they must be re-vetted and approved because things can change.
 - They can participate on Mission Sunday, but other date cannot conflict with the other Advertising in the Plaza.

PLC's Response:

- PLC discussed in line with these additions of the above statement intended to be supplemental to the POC Mission Fundraising Policy update.
- Once Ministry is approved, please connect with Mark Dittman if you need the current Policy Statement
- Revisit two events and World Mission Sunday and offer instead World Mission Sunday
 plus one additional week-end Mass lead time for Bulletin and Harvest table visibility
 (meaning, we should count World Mission Sunday as one of those three events)

Comments:

- 1. The way the outline on how we are to recruit is very off-putting.
- 2. If we have identified the person, it would be nice to have a packet of materials that has basic information on the process.
- 3. A person needs to know and see what he's signing up for, even if Father Paul approves, before making a decision.
- 4. Final approval of membership by Father Paul
- 5. Father Paul knows people, their gifts, so if he knew one, he has the liberty by his position to be able to make those recommendations before we go through our part.
- 6. If we're initiating the contact, and we're initiating someone to come and look at POC, then it needs to roll to him before we invite the person we are thinking of.
- 7. We need to go to Father Paul or send him a message, to tell him about inviting this person to POC, if he OK's it, then it will be almost like a final acceptance.
- 8. This process can work, but we need to give our potential members an education.
- 9. Does this apply to moving to another Commission after our three-year term has ended?
- 10. Take this home and write your comments on how to make it better. For discussion on next meeting
 - a. What am I supposed to be doing in the Commission?
 - b. First and foremost, we should have a heart for that particular Commission.
- 11. All of these are gifts and workings of the Holy Spirit. So, let's pray for the Holy Spirit's guidance to help us find what message He has for POC.

**** CSC Donations

- It's a consortium of several denominations in which St. John's is one of the key contributors, of helping people having difficulty, particularly, get back on their feet.
- The CSC Story and the work they do, ie., providing financial problem solutions, impending eviction assistance, advise how to navigate agencies to secure resources, etc.
- CSC is very similar to what St. Vincent de Paul does. But CSC stays with the clients longer. So, if SVdP meets the emergency, CFC will say 'now, how can we help you avoid having this same emergency in the future?'. They work with them to get a better job or to figure out their budget or whatever it is that will help meet the need.
- Why do we support this organization, instead of allowing them to fundraise?
 Because we're a part of the group of churches heading it. It is similar to the Compassion Clinic.
- Bill's the accountability person for reporting back to us, how they're doing, or if CSC is still well-run, or if it's still worth our support.
- The \$3,500 SJB's financial contribution to CSC has been approved by voting by POC members.
